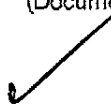



Pursuant to the provisions of Section 607.0124 or 617.0124, Florida Statutes, this corporation files these Articles of Correction within 30 days of the file date of the document being corrected.

These Articles of Correction correct the Articles of Incorporation filed with the Department of State on December 2, 2005.

Article IV, Capital Stock, the first paragraph states that "The maximum number of shares that this Corporation shall be authorized to issue and have outstanding at any one time shall be Ten Hundred Million (10,000,000) shares of Common Stock, par value \$.001 per share, and One Million (1,000,000) shares of Preferred Stock, par value \$.001 per share. Party." The inaccuracies are "Ten Hundred Million" and "Party." at the end of the paragraph.


The first paragraph should be replaced in its entirety with the following:

**"ARTICLE IV
CAPITAL STOCK**

The maximum number of shares that this Corporation shall be authorized to issue and have outstanding at any one time shall be Ten Million (10,000,000) shares of Common Stock, par value \$.001 per share, and One Million (1,000,000) shares of Preferred Stock, par value \$.001 per share."

The second paragraph of Article IV remains as stated.
