I, THE UNDERSIGNED, hereby come forth for the purpose of becoming a corporation under the Laws of the State of Plorida, by and under the provisions of the Statutes of the said State of Florida.

ARTICLE I

- c. To apply for, hold, purchase, acquire or otherwise deal in letters.
