ARTICLE X. BY LAWS

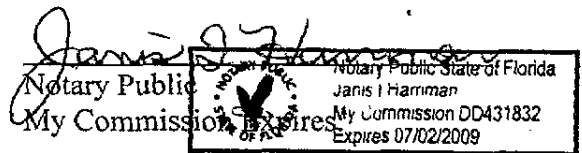
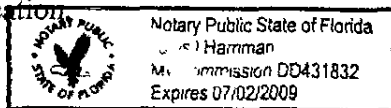

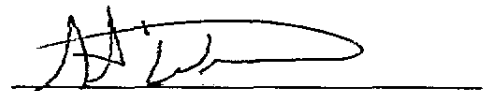
