The undersigned subscriber, Brett B. Hampton, competent to contract for the purpose of forming a corporation under the laws of the state of Florida, adopts the following Articles of Incorporation:

ARTICLE I

The name of the proposed corporation is: Hampton Pool Services, Inc.

The corporation may engage in any activity or business permitted under the laws of the United States of America and the state of Florida.


