ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION
OF
LNC INVESTOR SERVICES COMPANY

Pursuant to the provisions of Section 607.1003 and 607.1006 of the Florida Statutes, LNC INVESTOR SERVICES COMPANY, a corporation organized and existing under the laws of the State of Florida (the "Corporation"), hereby adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation is LNC Investor Services Company.
2. The original Articles of Incorporation for the Corporation were filed on December 5, 2005, and assigned document number P05000159331.
3. By written consent executed on July 21, 2006, by the Directors and sole Shareholder of the Corporation, respectively, the Directors and Shareholder have agreed that the Articles of Incorporation be amended to change the name of the Corporation to "CNL Investor Services Company". The amendment was approved by the Directors and sole Shareholder.
4. Article I of the Articles of Incorporation is hereby amended to read as follows:

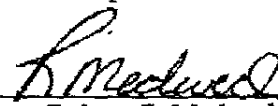
ARTICLE I
