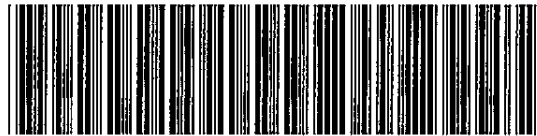

ARTICLES OF INCORPORATION

I, WALTER R. SPIKES JR., do hereby incorporate myself for the purpose of becoming a corporation for profit under Florida law.

ARTICLE I

The name of the corporation is: URBAN AUTO SALES, INC..

ARTICLE II

The corporation shall have perpetual existence.

ARTICLE III

This corporation is organized to engage in the retail sale of all kinds of used motor vehicles and provide financing services for the purchase thereof. The corporation may also conduct other related enterprises not prohibited by law.

ARTICLE IV

The aggregate number of shares of stock which this corporation may issue is Five Hundred Thousand (500,000), all of which shall be common shares with a par value of One Dollar (\$1.00) per share. Each shareholder has full preemptive rights to purchase shares held or owned by other shareholders of the corporation. Each shareholder of any class of stock of this corporation is also entitled to full preemptive rights to purchase any unissued or treasury shares of the corporation at the price at which such shares are offered to others.

Each shareholder of any class of stock of this corporation has full preemptive rights to purchase any corporate securities carrying rights of subscription to, and/or acquisition of, any unissued or treasury stock.

ARTICLE V

The business affairs of the corporation shall be managed by the shareholders.

ARTICLE VII

The business office of the corporation is: 3000 North Washington Boulevard, Sarasota, Florida 34234.

ARTICLE VIII

The corporation's legal existence will begin on the first day it is legally qualified to transact business in Florida.

ARTICLE IX

The corporation may indemnify any officer, agent, or other representative, when reasonable, to the fullest extent permitted by law.


