**ARTICLES OF AMENDMENT  
TO ARTICLES OF INCORPORATION OF  
VALET WASTE HOLDINGS, INC.

CHANGING NAME**

Pursuant to the provisions of Section 607.1005, Florida Statutes, the undersigned corporation, **VALET WASTE HOLDINGS, INC.**, a Florida corporation (the "**Corporation**"), adopts the following Articles of Amendment to amend its Articles of Incorporation to change its name:

1. **Name of the Corporation.** The name of the Corporation is Valet Waste Holdings, Inc. and its Florida document number is P05000159360

2. **Text of the Amendment.** The amendment is to change the Corporation's name. Accordingly, Article I of the Articles of Incorporation is amended in its entirety to read as follows:

**Article I  
Name**

The name of the Corporation is VWI Holdings, Inc.

3. **Date of Adoption.** The Amendment was adopted effective as of December 6, 2005.

4. **Manner of Adoption.** The Amendment was adopted by the sole Incorporator before the issuance of shares.
