



ARTICLE I

NAME

The name of the Corporation is Kiayana's Imagine This, Inc.. The principal office address and the mailing address of said Corporation is 4504 Misty Dawn Court South Jacksonville, Florida 32277.

ARTICLE II

DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE VI

INITIAL REGISTERED OFFICE AND AGENT

ARTICLE VII

INITIAL BOARD OF DIRECTORS

This corporation shall have two (2) Directors constituting the initial Board of Directors. The board of directors shall be appointed by the corporation's shareholders. The number of directors may be either increased or decreased from time to time by the bylaws;

officer, employee, or agent and shall inure to the benefit of the heirs, executors, and administrators of such a person.

This corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, or any amendment hereto, by a majority vote of the Board of Directors, and any right conferred upon the shareholders is subject to this reservation.
