This corporation may engage in any activity or business permitted under the laws of the United States and of this state.


ARTICLE IV CAPITAL STOCK

ARTICLE VII AMENDMENT

Those articles of Incorporation may be amended in the manner provided by law. - 2. We shoulded of the Corporation may self or number his stock in this corporation except to another individual who is eligible to be a shareholder of the corporation.

ARTICLE IX POWER OF CORPORATION

ARTICLE XII REGISTERED OWNERS


