**ARTICLES OF INCORPORATION
OF
BARAGANO & CARDOZO INVESTMENTS, INC.**

The undersigned, for the purpose of forming a professional service corporation under Florida Law, and who is a natural person competent to contract, does hereby adopt the following Articles of Incorporation:

ARTICLE 1

The name of this Corporation shall be **BARAGANO & CARDOZO INVESTMENTS, INC.**

ARTICLE 2

This Corporation shall have perpetual existence.

ARTICLE 3

This Corporation is organized for the purpose of engaging in investments.


ARTICLE 4

ARTICLE 10


