The corporation shall be deemed to commence existence of December 1, 2005.

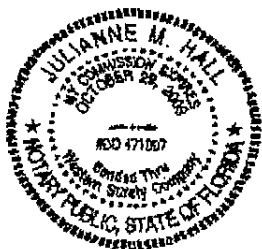
