The undersigned subscriber to these Articles of
Incorporation, being a natural person competent to contract,
hereby, for the purposes of forming a corporation under the laws
of the State of Florida, adopt the following Articles of
Incorporation for such corporation:

ARTICLE I

NAME: The name of the corporation shall be COLSON TITLE COMPANY, INC.
