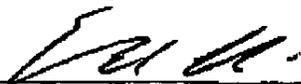

The Amended Articles were adopted by the Company's shareholders as of this 24th day of August, 2012.

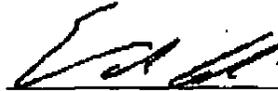
