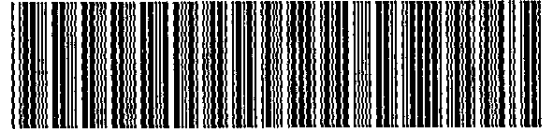

**ARTICLES OF INCORPORATION OF
LANSHE & CASAS, P.A.**

ARTICLE I - NAME

The name of the corporation shall be Lanshe & Casas, P.A.

ARTICLE II - OFFICES

The principal office of the corporation is fixed, and shall be located at Miami-Dade County. The corporation may have any other offices as the business of the corporation may require from time to time. The street address of the corporation's initial registered office is 1025 Kane Concourse, Suite 203, City of Bay Harbor Islands, County of Miami-Dade, State of Florida, zip code 33154 and the name of its initial registered agent at that address is Clare A. Casas.

ARTICLE III - PURPOSE

This corporation is organized for the following purposes:
