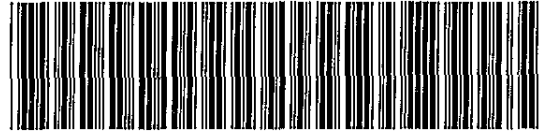

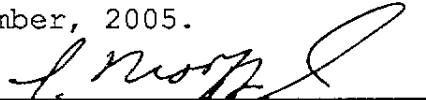
BY THESE ARTICLES OF INCORPORATION the incorporator forms a corporation for profit under Florida law.

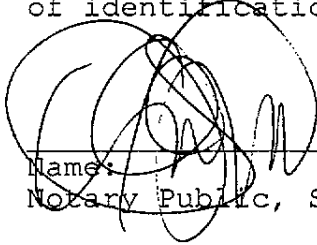

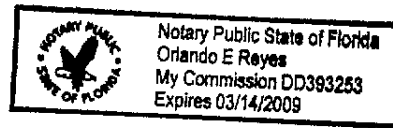

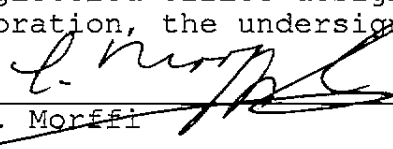
