The Corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

# ARTICLE 12: BYLAWS

The initial Bylaws shall be adopted by the Board of Directors. The power to after, amend or repeal the Bylaws or adopt new Bylaws is vested in the Board of Directors, subject to repeal or change by action of the shareholders.

#### ARTICLE 13: AMENDMENT

This Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment thereto, and any right conferred upon the shareholders is subject to this reservation.
