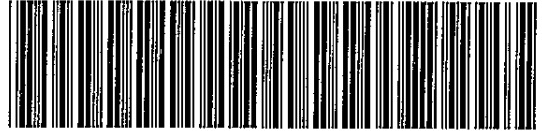

**ARTICLES OF INCORPORATION
OF
KK COUTURE, INC.**

The undersigned incorporators, for the purpose of forming a corporation under the Florida Service Corporation and Limited Liability Company Act, adopt the following Articles of Incorporation.

**ARTICLE I
NAME**

The name of the corporation is KK Couture, Inc. (hereinafter called the "Corporation")

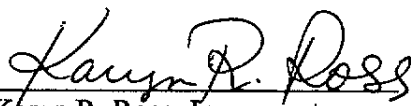
