ARTICLES OF INCORPORATION OF:

Wamich Corporation

The undersigned subscriber to these Articles of Incorporation is a Natural Person competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

ARTICLE I - NAME

The name of this corporation is Wamich Corporation (Hereinafter, "Corporation").

ARTICLE IX POWER OF CORPORATION
