



# ARTICLES OF INCORPORATION

**OF** 

Boss Motorsport, Inc.

ARTICLE I - NAME.

The name of this corporation is Boss Motorsport, Inc.

ARTICLE II - DURATION.

This corporation is to have perpetual existence beginning with the date of subscription and acknowledgment of these Articles of Incorporation which is December 7, 2005.
