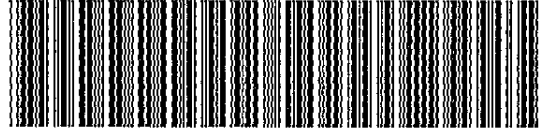

The name of the corporation is BELLE GLADE PAIN MANAGEMENT, INC.
