THE UNDERSIGNED, has executed the following document as incorporator of the above named corporation, a corporation organized under the laws of the State of Florida, and all the right duties and obligations of the undersigned as incorporator, and those of the corporation, are to determined in accordance with the laws of the State of Florida.

To purchase, take. Receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, ledge or otherwise dispose of and otherwise use and deal in and with

shares or other interest in, or obligations of, other domestic or foreign corporations, associations, partnerships or individuals or direct or indirect obligations of the United States or of any other government, state, territory, governmental district or municipality or of any instrumentality thereof;

To make contracts and guarantees and incur liabilities, borrow money at such rates of interest as the corporation may determine, issue its notes, bonds and other obligations and secure any of its obligations by mortgage or pledge of all or any of its properties franchises and incomes;

To lend money for its corporate purposes, invest and reinvest funds and take and hold real and personal property as security of the payment of funds so loaned or invested;

To be a promoter, incorporator, partner, member, associate or manager of any corporation, partnership, Joint venture, trust or other enterprise


ARTICLE IV
