**ARTICLE I - NAME AND BUSINESS ADDRESS**

The name of this Corporation is Bermello Ajamil Construction Services, Inc. Its principal office address and business mailing address is 2601 South Bayshore Drive, Suite 1000, Miami, Florida 33133.

**ARTICLE II - DURATION**

The Corporation shall have a perpetual existence.

**ARTICLE III - PURPOSE**

The purpose of this Corporation is to engage in any activities or business permitted under the Laws of the United States and Florida.


