We, the undersigned, have this day associated ourselves together for the purpose of forming a corporation for profit under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation is AMY C. WEBB REAL ESTATE AGENT, INC.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this Corporation shall be: 909 Wembly Lane, St. Augustine, Florida 32095.

ARTICLE III PURPOSE
