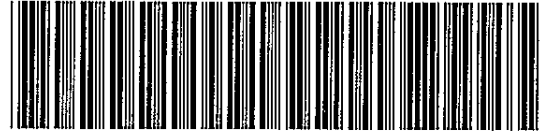

#### **ARTICLE I CORPORATE NAME**

stock shall be fully or partially paid, unless otherwise determined by the by the Board of Directors or before the time of issuance thereof.

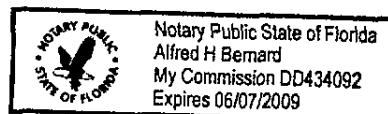
