

ARTICLES OF INCORPORATION OF

ESITrust, Incorporated

The undersigned subscriber to these articles of incorporation, a natural person competent to contract, hereby forms a corporation, for profit, under the laws of the State of Florida.

Article I

The name of the corporation is ESITrust, Incorporated.

Article II

This corporation is to exist perpetually unless dissolved in accordance with the laws of the State of Florida.

Article III

This corporation may engage in any activities or businesses permitted under the laws of the United States of America and the laws of the State of Florida

Article IV

The aggregate number of shares of stock that this corporation shall have authority to issue is ten million (10,000,000) shares of no par value, which shall be designated "common stock," and one million (1,000,000) shares of preferred stock. The board of directors shall have the authority to determine the rights, preferences, and voting power of the preferred stock.

Article V

The initial street address of the principal office of this corporation in the State of Florida is 609 1/2 Lake avenue, Lake Worth, Florida 33460, located in Palm Beach County. The Board of Directors may, from time to time, move the principal address to any other address in the State of Florida. This corporation shall have the privilege of establishing branch offices at such other places within and without the State of Florida or the United States of America as may be designated from time to time by the Board of Directors of the corporation.

Article VI

The name and address of the initial director_of the corporation is: Dan Kiely, 609 1/2 Lake avenue, Lake Worth, Florida 33460. The number of directors may be increased or diminished from time to time in accordance with the bylaws adopted by the shareholders.

Article VII

Article VIII
