#### **ARTICLE 1 - NAME**

The name of the Corporation is **INDEPENDENT LIVING SERVICES OF SOUTH FLORIDA INCORPORATED**, (hereinafter, "Corporation").

#### **ARTICLE 2 - PURPOSE OF CORPORATION**

The Corporation shall engage in any activity or business permitted under the laws of the United States and of the State of Florida.
