

ARTICLES OF INCORPORATION

TGW PRODUCTIONS, INC.

05 DEC 12 AM 8:42 The undersigned incorporator makes, subscribes, acknowledges and files with the Department of State of Florida these Articles of Incorporation for the purpose of forming a corporation for profit under the laws of the State of Florida.

ARTICLE I

NAME and ADDRESS

The name of the corporation is TGW PRODUCTIONS, INC.. The address of the corporation is 100 West Livingston Street, First Floor, Orlando, Florida, 32801.

ARTICLE II

TERM OF EXISTENCE

This corporation shall commence as of the date of the filing of these Articles of Incorporation with the Secretary of State and shall have perpetual existence.

ARTICLE III

NATURE OF BUSINESS

This corporation may engage in any activity or business permitted under the laws of the United States of America and of this State.

ARTICLE IV

CAPITAL STRUCTURE
