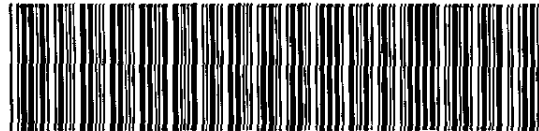

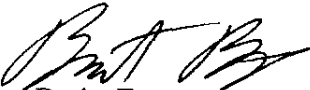

**ARTICLE I - NAME**

The name of this corporation is DCH Construction Services, Inc.

**ARTICLE II - ADDRESS**

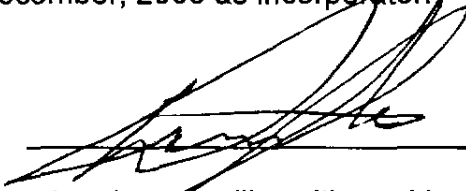
