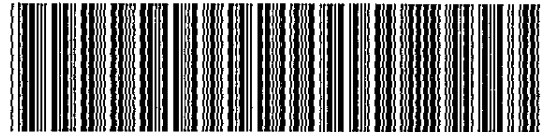



The undersigned incorporator of this corporation has executed this Article of Amendment on December 28, 2005.



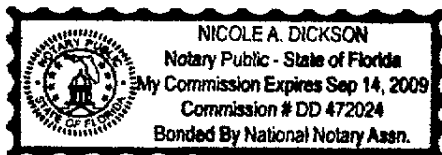
