The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation.

ARTICLE I - NAME

Section 1.1 <u>Name</u>. The name of the corporation is Southway Marketing, Inc.

ARTICLE II - INITIAL PRINCIPAL OFFICE AND MAILING ADDRESS
