ARTICLES OF INCORPORATION  
OF  
ORLANDO HEALTHCARE SYSTEM, INC.

ARTICLE ONE

The name of the corporation is ORLANDO HEALTHCARE SYSTEM, INC.

The period of its duration is perpetual.

The aggregate number of shares which the corporation shall have authority to issue is one thousand (1,000) of no par value.


ARTICLE FIVE
