

ARTICLES OF INCORPORATION



ARTICLE I - NAME

The name of this CORPORATION IS: JOSEPH KEITH MASON, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this the filing of these Articles with the Department of State.

ARTICLE III - PURPOSE
