**ARTICLES OF INCORPORATION OF
TOWNE PLACE/UCA-MM, INC.**

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

Article 1.

Name and Address

The name of the Corporation is Towne Place/UCA-MM, Inc. The principal office and mailing address of the Corporation is 7995-B Preserve Circle, Naples, Florida 34119.

Article 2.

Duration

The duration of the Corporation is perpetual.

Article 3.

Purpose

The general purposes for which the Corporation is organized are the following:

Preemptive Rights



The Corporation elects to have preemptive rights, pursuant to Section 607.0630, Florida Statutes, as amended from time to time.


Article 10.


