

### ARTICLES OF INCORPORATION

# ARTICLE I - NAME

The name of this corporation is Global Capital USA, Inc.

# ARTICLE II - PRINCIPAL OFFICE

The mailing address of this corporation shall be 7 1710 W. Cypress Creek Rd. Fort Lauderdale, Florida 33309

# ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.
