ARTICLES OF INCORPORATION

OF

CAMBOY INTERIORS PALM BEACH, INC.

The undersigned, acting as incorporators of a corporation under the <u>F</u> <u>Statutes</u>, adopt the following Articles of Incorporation:

First: The name of the corporation is:

CAMBOY INTERIORS PALM BEACH, INC.

Second: The principal office and mailing address of the corporation is:

249 Royal Palm Way Suite 303 Palm Beach, FL 33480

Third: The period of its duration is perpetual unless sooner dissolved.

Fourth: The general purpose or purposes for which the corporation is organized are to engage in the transaction of any and all lawful business for which corporations may be incorporated under the provisions of the <u>Florida Statutes</u>.
