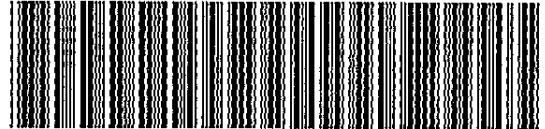

The undersigned incorporator, for the purpose of forming a Corporation for profit under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I- NAME

The name of this Corporation is:

The Corporation is to begin on January 1, 2006 and exist perpetually.

ARTICLE III PURPOSES

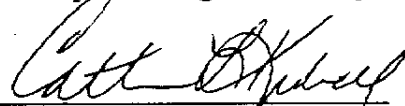
