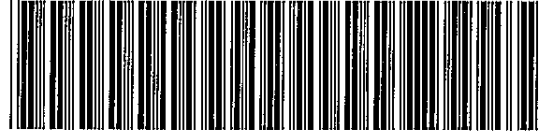

OF

I, THE UNDERSIGNED, being natural person(s) of legal age, hereby desire to form a S-corporation under the laws of the state of Florida, and hereby adopt the following Articles of Incorporation.

ARTICLE I

NAME

INDEMNIFICATION

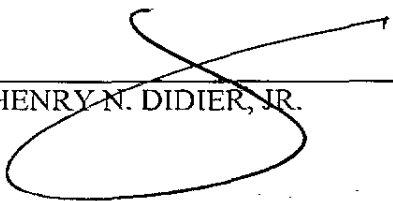

AMENDMENT

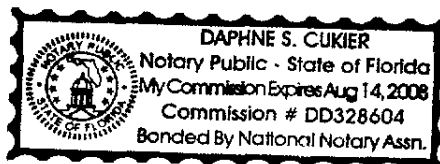

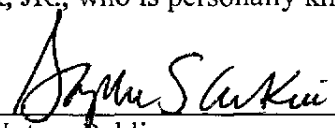
