**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
JP BORDERS INC.**

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act (the "Act"), the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation is JP BORDERS INC. (the "Corporation"), Charter #P05000163842.
2. The following Amendment to the Articles of Incorporation was adopted by all of the Directors of the Corporation and the sole Shareholder of the Corporation, the number of votes cast being sufficient for approval, on January 4, 2006 in the manner prescribed by Section 607.1003 of the Act.
3. Article I of the Corporation's Articles of Incorporation is hereby deleted and replaced by a new Article I and Article VI, as follows:

"ARTICLE I"

The name of the Corporation is SOUTH FLORIDA BORDERS INC. (the "Corporation")."

"ARTICLE VI"

The name of the director/officer to these Articles of Incorporation is:


