ARTICLES OF INCORPORATION OF CASTLE HAULING CORP.

We, the undersigned, hereby associate ourselves together and make, subscribe, acknowledge and file these Articles of Incorporation with the Secretary of State of the State of Florida for the purpose of becoming a corporation for profit under the laws of the State of Florida.

ARTICLE I

The name of the corporation shall be: CASTLE HAULING CORP.

ARTICLE II

This corporation shall have perpetual existence.

ARTICLE III

The purpose of this corporation is to engage in any lawful activities or business permitted under the laws of the United States and of Florida.

ARTICLE IV

The maximum numbers of shares of stock shall be 500 of the par value of One Dollar (\$1.00) per share, all of which shall be common stock.

ARTICLE V

The amount of capital with which this corporation shall begin business is not less than Pive Hundred Dollars (\$500.00).

ARTICLE VI

The principal office of the corporation shall be located at 420 SE 17TH ST., CAPE CORAL, FL 33990, but the corporation shall have the power to establish branch offices and other places of business at such other places within or without the State of Florida as may be determined or deemed expedient.
