OS OR IS PLED 39 We, the undersigned, do hereby associate ourselves together and subscribe These Articles of Incorporation for the purpose of forming under the laws of state of Florida, Charter 607 and subject to the fallowing provisions:

### <u>ARTICLE ONE</u>

The name of the Corporation shall be:

EROPALSA, INC

#### ARTICLE TWO

This corporation shall have perpetual existence and may engage in any activity or business permitted under the laws of the United states and of the State of Florida.

The general nature of business to be transacted by this corporation shall be:

a) This Corporation is organized for the purpose of engaging in a business organized under Florida General Corporation Law, Chapter 607, Florida Statutes.

b) To manufacture, purchase or otherwise acquire, and to own, mortgage, pledge, sell, assign, transfer or otherwise dispose of, and invest in trade in, deal in and with, goods, wares, merchandisc, real and personal property, and services of every class, kind and description.
