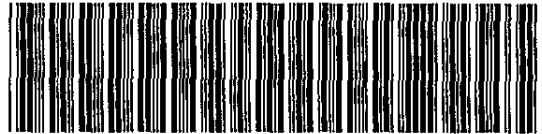



ARTICLE I. NAME

The name of this corporation shall be DIANNE M. KENNY ENTERPRISES, INC.

ARTICLE II. TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE III. NATURE OF BUSINESS

This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IX. AMENDMENTS


