

ARTICLES OF INCORPORATION

By these Articles of Incorporation, the undersigned Subscriber forms a corporation in accordance with Chapter 607, <u>Florida Statutes</u>, and pursuant to the following provisions ("Articles"):

ARTICLE I NAME

The name of the corporation shall be 1320Stompers.com, Inc., and, for convenience, shall be referred to in this instrument as the "Corporation".

ARTICLE II DURATION

The Corporation shall exist perpetually unless and until dissolved according to law. Corporate existence of the Corporation shall commence upon the filing of these Articles with the Florida Department of State.

ARTICLE III PRINCIPAL OFFICE AND MAILING ADDRESS

The street address and mailing address of the initial principal office of the Corporation is 5110 Seiler Court, Melbourne Beach, Florida 32951.

ARTICLE IV REGISTERED OFFICE AND AGENT

The street address of the Corporation's initial registered office is 5110 Seiler Court, Melbourne Beach, Florida 32951. The name of the Corporation's initial registered agent at that office is Brian Odom.

ARTICLE V PURPOSES AND POWERS OF THE CORPORATION

The number of directors may be increased or adjusted in the manner set forth in the Bylaws, provided that the number shall never be less than one. The method of election and term of office, removal and filling of vacancies of the Board of Directors shall be as set forth in the Bylaws.
