

#### ARTICLES OF INCORPORATION

### PAINTING 4 U,INC.

The undersigned, acting as incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

#### ARTICLE I

The name of the corporation is: PAINTING 4 U, INC.

#### **ARTICLE II**

The period of duration of the corporation is perpetual.

#### ARTICLE III

The purpose or purposes for which the corporation is organized is to engage in any type of activity, within or without the United States which is lawful under the laws of the United States and the State of Florida.

#### **ARTICLE IV**

The street address of the initial principal office of the corporation and the mailing address of the corporation is: 100 S.E. 3rd Avenue, Apt. 100, Boca Raton, FL 33432.

#### **ARTICLE V**

The total authorized capital stock of this Corporation shall consist of Fifty Thousand (50,000,) shares of voting common stock, having a par value of \$.001 each, amounting in the aggregate to Fifty Dollars (\$50.00). All

stock when issued shall be fully paid for and shall be nonassessable and shares of the Corporation are not to be divided into classes.

The holders of the outstanding capital stock shall be entitled to receive, when and as declared by the Board of Directors, dividends payable either in cash, in property, or in shares of the capital stock of the corporation.
