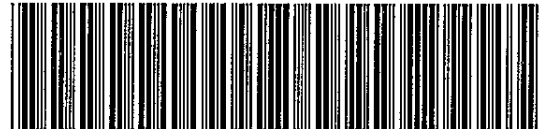

OF
GRANT REAL ESTATE ADVISORS, INC.**

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, and in compliance with Chapter 621, Florida Statutes, hereby adopts the following Articles of Incorporation.

ARTICLE I: CORPORATE NAME

The name of this corporation shall be **GRANT REAL ESTATE ADVISORS, INC.**

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation is 625 Regatta Road, Naples, Florida 34103.

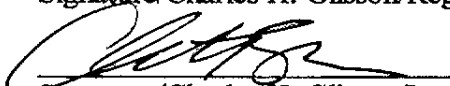
