In compliance with the requirements of F.S. Chapter 607, the undersigned, being of legal age and a natural person, do hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation under the laws of the State of Florida.

ARTICLE I.

The name of the Corporation ("Corporation") is Vice City Vixen Productions, Inc.

ARTICLE II.

This Corporation shall commence its existence immediately upon the execution of these Articles of Incorporation and shall exist perpetually thereafter unless sooner dissolved according to law.
