The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE I**

**Corporate Name and Principal Office**

The name of this corporation is SLS of Tampa Bay, Inc. and its principal office and mailing address is 231 21<sup>st</sup> Ave., St. Pete Beach, FL 33706.

**ARTICLE II**

**Commencement of Corporate Existence**

The corporation shall come into existence on the date of filing with the Florida Secretary of State.

**General Nature of Business**

The corporation may transact any lawful business for which corporations may be incorporated under Florida law.

### By-Laws


