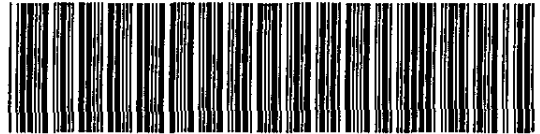

ARTICLE I

Corporate Name and Principal Office

EFFECTIVE DATE

01-01-06

The name of this corporation is **WEBISODICS ONLINE, INC.** and its principal office is located at 17324 Whirley Road, Lutz, Florida 33558.

ARTICLE II

Commencement of Corporate Existence

The corporation shall come into existence on January 1, 2006.

ARTICLE III

General Nature of Business

This corporation may engage in any activity or business permitted under the laws of the United States or of the State of Florida.

Capital Stock
