The power to adopt, alter, amend or repeal by-laws shall be vested in the shareholders.

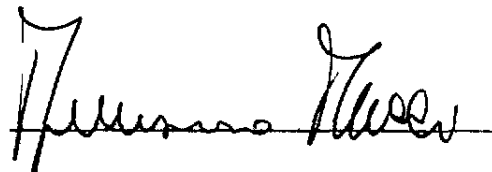
ARTICLE XII -- INDEMNIFICATION

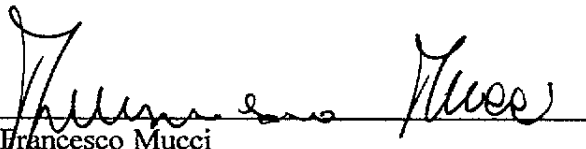

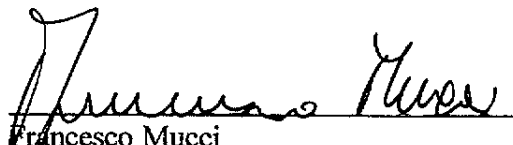
