SECRETARY OF STATE

The undersigned, acting as sole incorporator, adopts these Articles of Incorporation and forms a profit corporation (the "Corporation") under the Florida Business Corporation Act (the "Act"), as follows:

**I.****Name**

The name of the Corporation is **Circle of Services Real Estate Assistance Company, Inc.**

**II.****Term of Existence**

The date when corporate existence will commence is December 21, 2005 in accordance with Section 607.0203(1) of the Act. The Corporation will have perpetual existence thereafter.

**III.****Principal Office**

The principal office and mailing address of the Corporation are 32801 U.S. Highway 19 North, Palm Harbor, Florida 34684.

**IV.****Capital Stock**

The Corporation is authorized to issue 7,500 shares of \$1.00 par value common stock, which will be designated Common Stock.


