In compliance with the requirements of Florida Statutes, Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

EFFECTIVE DATE

01-01-06

The name of this corporation (the "Corporation") is BLOCKER REALTY INCORPORATED.

ARTICLE II

The existence of the corporation shall be perpetual and begin on January 01, 2006.

ARTICLE III

The street address of the principal office of the Corporation is 401 North Atlantic Avenue, Apartment Number 103, New Smyrna Beach, Florida 32169.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is one hundred thousand (100,000), all of which shall be Common Shares.
